## INTRODUCTION

As per the Gujarat Agricultural University Act 2004 (Gujarat Act No. 5 of 2004) the erstwhile Gujarat Agricultural University was divided into following four Universities :

1. Junagadh Agricultural University (JAU), Junagadh
2. Anand Agricultural University (AAU), Anand
3. Navsari Agricultural University (NAU), Navsari
4. Sardarkrushinagar Dantiwada Agricultural University (SDAU), Sardarkrushinagar

All above mentioned Agricultural Universities here-in-after will be referred as “State Agricultural Universities (SAUs)” of Gujarat State. These SAUs offer various Post Graduate (PG) degree programmes through the constituent colleges of each University, i.e. Master's Degree Programme of two years (4 semesters) duration and Doctoral Degree Programmes of three years (6 semesters) duration.

The admissions on 70% seats of total intake of PG programmes are reserved for Gujarat domicile and pass-out students of SAUs of Gujarat State / ICAR accredited SAUs of other states. Remaining vacant seats, if any, may be filled by pass-out students of SAUs of Gujarat and non-domicile of Gujarat State. Rest of the 30% seats of total intake is reserved for students nominated by Indian Council of Agricultural Research (ICAR) AIEEA (PG) 2024.

For conducting Common Admissions for Post Graduate Programmes Vice Chancellor, JAU, Junagadh is nominated as “Nodal Officer for Common Admissions for Post Graduate Programmes of SAUs”, moreover, “Central Admission Committee” with following members are formed for performing all duties / responsibilities related to this admission :

1. The Registrars of SAUs
2. The Director of Research & Dean, PG Studies of SAUs
3. Deans of faculties of SAUs
4. Member secretary of Council of SAUs or representative of State Council nominated by Member Secretary

The SAUs of Gujarat State have most of the Post Graduate degree programmes in common; hence, the Central Admission Committee takes the responsibility of admission to PG degree programmes commonly offered by SAUs, viz., Agriculture, Horticulture, Agricultural Engineering and Technology, Food Technology, Agricultural Information Technology, Forestry, Community Science and Agri-Business Management. However, if any additional PG degree programme is offered by only one of the SAUs, then

responsibility of admission to that PG programme shall be of that particular University.

## ELIGIBILITY FOR ADMISSION

### 1. DOCTORAL DEGREE PROGRAMME

Gujarat domicile and pass-out students of SAUs of Gujarat State / ICAR accredited SAUs of other states shall be eligible. Remaining vacant seats if any may be filled by pass-out students of SAUs of Gujarat and non-domicile of Gujarat State shall be considered.

Candidate should have Master's degree in respective discipline for admission to doctoral degree Programme of SAUs of Gujarat State.

A candidate for admission to the Doctoral Degree Programmes (Ph.D.) (3 Years or 6 Semesters duration) should have minimum requirement of marks at the Master's degree level as under:

Gujarat domicile and pass-out students of SAUs of Gujarat State / ICAR accredited SAUs of other states shall be eligible. Remaining vacant seats, if any, may be filled by pass-out students of SAUs of Gujarat and non-domicile of Gujarat State shall be considered.

A candidate for admission to the Master's Degree Programmes (2 Years or 4 Semesters duration) should have minimum requirement of marks at the bachelor degree (UG) level as under:

- ❖ The admission requirements shall be relaxed by maximum five percent for an employee of the University nominated for Master's and Doctoral Degree Programmes of other SAUs / Institutes of Gujarat as well as employees nominated by State / Central Government or ICAR and candidates having three years' experience.
- ❖ Employees of the Agricultural Universities of Gujarat, in-service trainees as well as employees nominated by State or Central Government or ICAR or other Agricultural Universities or Institutes / other organizations shall not be required to appear in the entrance test.
- ❖ Candidate pass-out from private Universities / Colleges not approved by State Government as well as not accredited by ICAR will not be considered eligible for Common admission for Post Graduate Programmes of SAUs. Such candidates will not be permitted even in to appear the entrance test for the above admission.

**Note:** The benefit of the highest level of marks obtain in any one of the above category shall be given to the student only once during his / her university career.

### ADMISSION PROCEDURE

Admissions shall be generally given at the beginning of odd semester only, subject to the intake capacity and other infrastructure facilities available at the respective university.

The Registrar, JAU, Junagadh shall give advertisement on website **pg.gsauca.in** mentioning key dates for common admission to PG degree programmes of SAUs of Gujarat State. The interested students of SAUs of Gujarat State shall pay prescribed fee online and duly filled-in admission form and also submit hard copy of the same to “The Registrar, JAU, Junagadh” on or before prescribed last dates.

The Director of Research & Dean, PG Studies of the host institute shall appoint Dean / Principal of the concerned faculty as convener of the scrutiny committee. Thereafter, Convener of the faculty shall constitute a committee at college level for scrutinizing applications for Post Graduate admission and shall submit the list of eligible candidates to the Registrar, JAU, Junagadh for uploading on website "**pg.gsauca.in**".

The eligible candidates shall be required to remain present on prescribed date, time and place for appearing in entrance test for common admission to PG degree programmes of SAUs of Gujarat State.

The entrance test shall be either computer based mode or OMR based and question papers shall comprise of 100 Multiple Choice Questions (MCQs) and duration of examination shall be of 1 (one) hour.

The basis of selection of candidate for the admission shall be the merit. The cut off marks for eligibility is 45% in the entrance test. The merit list shall be prepared for eligible candidates giving 50:50 weightages to the marks of OGPA (percentage marks) of the last degree and common entrance test (except M.B.A. (ABM)). The merit for admission to M.B.A. (ABM) shall be on entrance test only. Additionally the marks of sports / cultural activities shall also be added before preparing the merit list. Separate merit list for Gujarat domicile students pass-out from SAUs of Gujarat State / ICAR accredited SAUs of other states and non-domicile of Gujarat state students pass-out from SAUs of Gujarat shall be prepared for each degree / subject / discipline.

**Note:**

- (1) Provisions are made for online examination at four centers *viz.*, Junagadh, Anand, Navsari and Sardarkrushinagar.
- (2) Further for counselling, students shall have to remain present at any one of the four centers *viz.*, (i) JAU, Junagadh (ii) AAU, Anand, (iii) NAU, Navsari and (iv) SDAU, Sardarkrushinagar.
- (3) Candidates shall have to mention the center of choice for both online entrance test as well as counselling in the application form.

The candidates shall remain present on prescribed date, time at place mentioned in application for counselling. The aforesaid admission committee shall admit candidates as per his / her merit and availability of seats however; the admission shall be treated as confirmed only on receipt of admission fee at the time of counselling. Therefore, all candidates must come well prepared for the payment of prescribed fee at the time of counselling. Once the candidates are admitted, one may not be permitted for change of subject / discipline / college / university. The decision of the admission committee shall be final in all respect. Such admitted candidates shall have to report to respective college / university on prescribed date.

All the post graduate seats (except ICAR Quota) shall be filled-up from the candidates of domicile of Gujarat / ICAR accredited SAUs of other states, but if any seats remain vacant from students of Gujarat origin, such vacant seats may be filled up by the candidates of other states and pass-out from SAUs of Gujarat State.

## **RESERVATION OF SEATS**

### **General Conditions regarding Reservation**

A candidate availing benefit of seats earmarked for the categories shall be required to produce the certificate of his / her belonging to a particular group, i.e., ST / SC / SEBC / EWS from the competent authority of Gujarat State. The candidates belonging to SEBC should produce the "Non creamy layer certificate" in the prescribed format issued by the competent authority of the Gujarat State with validity as per the resolution No. SSP / 122015 / 455246 / A Dt. 26/04/2016 and Implementation of 10% reservation of Economically Weaker Sections (EWS), as per vernacular Resolution No. GKV - 162019 - 752 - K.2 / 45903 / A Dt. 11.02.2019 issued by the Government of Gujarat, Agricultural, Farmer Welfare and Co-operation Department, Gandhinagar with respect to give effect to the provision of the Constitution for all higher educational institutions funded / aided, directly or indirectly, by the Government of Gujarat. The candidates shall be granted admission in EWS category subject to fulfillment of all the conditions as per rules of Govt. of Gujarat.

A candidate availing benefit of reserved seat as above shall be required to produce a valid certificate from the competent authority of the state, stating that he / she belongs to a particular group of Economic Weaker Section, from the competent authority of the state as per guideline from the *time to time*.

Reservation of seats shall be as per the roster prescribed by Government of Gujarat from *time-to-time*.

If the need arises on account of vacant seats due to less number of applications in one group and shortage of seats due to more number of application of eligible candidates in the other group, reciprocal adjustment in the above specified SC (7%) and ST (15%) seats between the two groups will be made.

If applications from backward class candidates are more than the reserved seats earmarked for them as above, admission will be given to them strictly on *inter se* merit within each of the only two groups.

### Reservation for Differently abled (Persons with Disabilities - PwD)

Five percent seats are reserved for the persons with Disabilities candidates of Gujarat State which are adjustable within the respective category and subject / discipline to the following conditions:

- A candidate, having locomotors disability of one leg and partial arm, shall be eligible to apply for admission to a degree programmes course, subject to the submission of a certificate to that effect from the Civil Surgeon / Medical Superintendent of the Government Hospital based on the opinion of

the concerned specialist, that the locomotor's disabled candidate is in a position to undertake the degree programme and can perform the functions of the concerned field. The admissions will be on the basis of *inter se* merit only.

- The admission of a student of a reserved category on a reserved seat shall be valid subject to the verification of certificate issued by the authority empowered in this behalf. In case the certificate is found invalid on verification, he / she shall not have right to claim his / her admission on reserved seat and if he / she has been already granted admission, such admission shall be cancelled at any point of time.

Candidate shall not be admitted to Post Graduate Programmes of any discipline, if he / she suffers the following disabilities, namely:

- a) Disability of total body including disability of chest or spine more than 50%.
- b) Disability of lower limb of more than 50%
- c) Disability of upper limb
- d) Visually handicapped candidates and those with hearing disability
- e) Candidates with progressive diseases like myopathies, etc.
- f) Disabilities which otherwise would interface in the practical during study period.

### **Reservation for Candidates nominated by ICAR**

Thirty percent (30%) of the total number of seats earmarked for out-state candidates shall be reserved for the candidates nominated by the Indian Council of Agricultural Research (ICAR), New Delhi for Post Graduate courses on the basis of All India Entrance Test, subject to fulfilling minimum criteria laid down by SAUs of Gujarat State for admission.

- In case of transfer of admission from one faculty to another by admission committee during the admission process, the fees shall be refunded after deducting the processing charge of Rs 1000/- from admission Fees.

## **REPORTING AT COLLEGE LEVEL**

- A candidate selected for admission shall report to the Dean / Principal of the concerned college on the date specified by the concerned University for the purpose of first registration.
- The First registration shall include following:

  - (2) Submission of original documents at respective college
  - (3) Migration Certificate (candidates other than SAUs of Gujarat)
  - (4) Orientation

- The admission of the candidates who fail to report on the specified date shall be treated as cancelled.
- A candidate who is not in a position to report on the specified date due to unavoidable circumstances may register by paying fee through post or by a messenger on or before the date specified for registration.
- A fresh post graduate student, if joins service before submitting the thesis / project work, his / her registration shall automatically be cancelled.
- A student enrolled in the University shall be given a registration number which shall have to be used along with his / her name in all the documents and correspondence pertaining to him / her with the University.
- An Identity Card shall be issued to each registered student on completion of the first registration. The student shall carry it with him / her at all times and show the same on demand. In case the Identity Card is lost, a duplicate card shall be issued to him / her on payment of prescribed fee.

  - (v) Provisional Passing Certificate / Provisional Degree Certificate (Last Degree)
  - (vi) Degree Certificate (Last Degree)
  - (vii) Caste Certificate in case of SC / ST and SEBC or EWS candidate of Gujarat State from competent authority of the Gujarat State.
